Throughout the past year, changes such as the inclusion of an in-house custodial crew and the addition of our Facilities Supervisor, Yong Heo, have resulted in a number of cost-savings for the library. These savings are now providing us with the opportunity to bring additional tasks in-house for more customized service.

Heo secured three quotes from local vendors for the purchase of a riding carpet extractor machine. This machine will provide our in-house crew with the ability to both vacuum and shampoo the carpets with speed and relative ease. Currently, vacuuming is performed daily by in-house staff, covering sections of the library using an industrial backpack vacuum. Each section of the library is vacuumed about once per week in this setup. Carpet cleaning is performed monthly in sections along with a more in-depth quarterly regimen by an outside vendor, requiring oversight from internal staff. Each section of the library can expect to be cleaned at least once per quarter.

With the purchase of an extractor, vacuuming and cleaning will be completed at the same time, and each section of the library can expect to be more thoroughly cleaned once per week. The machine will require less physical exertion from facilities staff. It will also save staff time in providing afterhours oversight for outside vendors.

Of the quotes provided, I recommend the proposal from Lansing Sanitary Supply for the CHARIOT3 iEXTRACT 26 DUO totaling \$18,400.50. As our primary custodial supply vendor, we are very satisfied with their level of service. Aside from providing the lowest price for our desired unit, they have included a number of upgrades to their quote setting them ahead of their competitors.

Below is a chart to summarize the proposals obtained. Quotes on the product are attached to this memo. Facilities Supervisor, Yong Heo, will be attending the meeting to answer any questions board members may have about the proposals.

The warranty commences on the purchase date by the original end user from an authorized Kärcher agent, subject to proof of purchase. The machine must be registered at the time of purchase, if proof of purchase cannot be identified; the warranty start date is 90 days after the date of sale to an authorized Kärcher distributor.

- 2 year on site labor (3 hours max.) for all equipment with 2 year labor coverage as specified below. Excluded is impact damage, removal of foreign matter around brooms or brushes, minor adjustments such as broom or brush replacements, improper pressure settings, fuse replacement, squeegee blade angle adjustments, suction path blockage, machine or filter cleaning, failure to observe daily, weekly, monthly machine and battery maintenance procedures as prescribed in the supplied operator manual.
- **Wear Items** such as accessories, motor carbon brushes, squeegees, brushes, brooms, filters, tires, hoses, floor tools, hand tools, sealing strips, belts, etc. are excluded from chart coverage below and carry warranty coverage of 90 days from the in-service date.
- Vacuum motors are warranted for one year parts and labor without evidence of rust, corrosion, chemical damage or foreign matter. Long life vacuum motors (brushless) are warranted for 3 years parts, 2 years labor without evidence of rust, corrosion, chemical damage or foreign matter.

It is time to renew the library's dental insurance program. We received a quote for services through Delta Dental, the library's current provider. This renewal offers a 4.76% decrease over the current year's rates.

This plan is competitive with other employers from a plan design standpoint. It includes pediatric dental coverage, which is required as part of the Affordable Care Act. We are currently waiving the pediatric dental coverage offered from BCN as Delta Dental is a more cost effective strategy. This plan also includes orthodontic coverage, which can be a challenge to find a carrier that will do this when enrollment is less than 25 employees.

In addition to approving the renewal for January 2023, I am recommending that we renew again in July 2023 to match our renewal timeline for health insurance. This will provide the library with one renewal and open enrollment period per year, simplifying our internal processes and communication.

The Personnel Committee agreed with both of these measures. I recommend the approval of the updated renewal from Delta Dental at an anticipated annual cost of \$15,124.44 with the option to re-bid at the same time as our medical insurance renewal in May 2023.

Feedback from full time staff has indicated that the library's current vision reimbursement program was not adequate in meeting the needs of our staff and their families. Recognizing that a vision insurance program would cost roughly the same as we currently budget for vision reimbursements, I asked Kapnick, the library's insurance broker, to send us quotes for an employer-paid plan.

Of the quotes attached to this memo, I, along with the support of the Personnel committee, recommend Option 1. This option leverages our existing relationship with Delta Dental to limit staff time in benefits administration. This quote allows for annual access to exams, contacts, and lenses, however it provides cost savings in limiting frame purchases to every 24 months. This is anticipated to cost the library \$1,985.52 annually. Approximately \$3000 has been set aside for vision reimbursements in the upcoming fiscal year.

I recommend that we move forward with the quote provided by Delta Vision with an anticipated annual cost of \$1,985.52 with the option to re-bid alongside our medical insurance in May 2023.
