

## RESOLUTION REGARDING EXTENSION OF EMERGENCY PAID SICK LEAVE AND EMERGENCY FMLA BENEFITS

At a meeting of the Library Board of the Plymouth District Library ("Library"), Wayne County, Michigan, held electronically on the 15th day of December, 2020, at 7:30 p.m.

Whereas the Plymouth District Library ("Library") is a district library established pursuant to the District Library Establishment Act, 1989 PA 24; and

Whereas the Library, pursuant to a Resolution approved by the Library board on June 13, 2020 ("6/13/20 Resolution") currently provides emergency paid sick leave and emergency FMLA expanded benefits to employee in accordance with the Families First Coronavirus Response Act (FFCRA); and

Whereas the FFCRA is set to expire December 31, 2020; and

Whereas the 6/13/20 Resolution does not provide authorization for emergency paid sick leave and emergency FMLA beyond December 31, 2020; and

Whereas the Library Board has been asked to consider approval of an extension of emergency paid sick leave and emergency FMLA benefits in the event the FFCRA is not extended; and

Whereas legal review and approval has been obtained.

## It is *Resolved*, that:

- 1. the Library shall provide up to 80 hours of paid sick leave to all full-time and part-time employees unable to work or telework due to any of the qualifying reasons and under the terms and conditions as set forth in the 6/13/20 Resolution;
- 2. the Library shall provide up to 12 weeks emergency expansion of FMLA benefits for eligible employees who are unable to work or telework due to a need to care for their child when the school or child care has been closed, or the regular childcare provide is unavailable due to a public health emergency with respect to COVID-19, under the terms and conditions set for in the 6/30/20 Resolution:
- 3. in the event the FFCRA is extended beyond December 31, 2020, this Resolution shall become null and void and the Library will comply with terms and conditions set forth in any applicable Act extending FFCRA benefits;
- 4. Emergency paid sick leave and emergency FMLA benefits authorized under this Resolution shall be provided only for the period January 1, 2021 through \_\_\_\_\_\_\_\_\_,

2021, unless terminated earlier by further Resolution of the Library board.
