

## RESOLUTION OF BOARD OF TRUSTEES OF THE PLYMOUTH DISTRICT LIBRARY AUTHORIZING LEVY OF $\underline{1.4448}$ MILLS

On motion of Trustee, and seconded by Trustee, the following Resolution was presented:
WHEREAS the Board of Trustees of the Plymouth District Library has given due reflection to the Budget and Operation requirements of the Plymouth District Library and as to the 2021 fiscal year; and
WHEREAS the said Board of Trustees is desirous of providing for the appropriate certification of the <a href="Budget and Operation">Budget and Operation</a> millage relative to the said Plymouth District Library;
NOW THEREFORE BE IT HEREBY RESOLVED that as to the 2021 fiscal year of the Plymouth District Library, and as to that portion of said district within the City of Plymouth and the Charter Township of Plymouth, the extra <u>voted</u> millage for District Library operational purposes shall be the amount of <u>1.4448</u> mills.
BE IT FURTHER RESOLVED that the foregoing amounts are hereby levied by the Board of Trustees of Plymouth District Library and the Secretary of the Board of Trustees is hereby authorized and directed to report the same as the district library tax levy to the proper assessing officer or officers of the appropriate agencies and the Secretary may provide copies of the within resolution when requested by any such appropriate agency.
BE IT FURTHER RESOLVED that the amounts herewith certified to shall pertain to the fiscal year of the Plymouth District Library commencing January 1, 2021 except as subsequently altered or amended by appropriate certification.
BE IT FURTHER RESOLVED that a certified copy of the within and foregoing Resolution may be issued with like force and effect as though the original hereof and with the certification hereinafter provided for appended hereto.
